2. Terms of payment

The amount is due after receipt of the invoice.

3. Stornierung/ Rücktritt

The following cancellation fees plus VAT will be charged:

For cancellation by 31.05.2021: 50% of the total amount.

For cancellations after 31.05.2021: 100% of the total amount.

Cancellation must be declared in writing. If the organiser is unable to hold and/or provide the event due to a circumstance for which neither it nor the exhibitor/sponsor is responsible, the claim to reimbursement of the booking fee shall not apply. If the event that has begun cannot be properly continued due to force majeure, the virtual exhibitor/sponsor shall not be entitled to a refund or waiver of the booking fee.

4. Supply of data and information
